session of Board of Directors.

After resigning from his position as Vice Chairman of the Company, Mr. Zhuang

Wei will continue to serve as a director on the eleventh session of Board of Directors

of the Company.

by all members of the Nomination Committee of the Board of Directors of the Company,

and it has been agreed to be submitted to the Board of Directors for review.
